### TRACKING TEST INFORMATION TEST LIMITED TO 5 TD ENTRIES

**CLOSING DATE** for this TD test is November 18, 2010, **6:00 PM CST** after which time entries cannot be accepted or changed.

**ENTRY FEE: \$50.00** (includes \$0.50 AKC recording & \$3.00 Event Service fees). Fees must be paid in U.S. Funds. Fees payable to **DFWTC.** Non-titled TD entries MUST be accompanied by original certification by an authorized AKC tracking judge.

**ELIGIBILITY:** This test is open to all registered dogs at least 6 months of age who possess an AKC tracking title or who have passed a certification track by an authorized AKC tracking judge.

ENTRY LIMITATIONS: In accordance with AKC Tracking Regulations, entries in this test will be accepted up to the official closing date and time, even though the advertised limits may have been reached. Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the test will be held Thursday, November 18, 2010 at 7:00 PM CST at the home of the secretary, 602 E. Blakely, Rush Springs, OK 73082. The public is invited. The drawing will be conducted by the Test Secretary and shall be completely random among all entries received, except that preference shall be given to dogs that have not earned an AKC TD title, all remaining entries shall be similarly drawn and assigned a position on the Alternates List, subject to the same preferences set forth above.

**ACKNOWLEDGEMENT:** Draw order will be mailed by the Test Secretary after the closing of entries. Should such an acknowledgement not be received by the exhibitor within reasonable time, please notify the Test Secretary at 580-656-2217 or cmo0503@sbcglobal.net. Acknowledgements may be obtained via email by providing your email address on entry.

**TEST INFORMATION:** In the event an accepted entry withdraws following the closing of entries,

the Test Secretary shall contact the alternates according to their placement on the Alternates List. Upon such notification, alternates shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the Test Secretary to determine if alternates are present and, by their position on the Alternates List, determine which of the alternates shall participate.

Entry fees will not be refunded in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from participation by action of the Test Committee. Entry fees will be refunded for: (a) an alternate who does not participate, (b) an entrant who withdraws after the close of entries, provided an alternate runs in its place, and (c) an entrant who withdraws in writing before the stated closing date/time. Refunds will be mailed within seven (7) days following the test.

If it becomes necessary for any entrant to withdraw please notify the Test Secretary in writing as soon as possible so that an alternate may have a chance to fill your entry.

**TEST HEADQUARTERS:** South Parking Lot, Tarrant County College Northwest Campus (see map on next page).

**ALL ENTERED DOGS** must be at Test Headquarters by **8:00 AM o**n November 28, 2010 for the draw. A drawing will be held for track running order. The first track will be run as soon thereafter as is practical after it has aged the proper length of time. In the event of any absentee(s) among confirmed entries, the next alternate in catalog order who is present will be allowed to fill the vacancy.

**BITCHES IN SEASON** may participate subject to provisions set forth in the latest Tracking Regulations.

**EXHIBITORS TAKE NOTE:** The DFW Tracking Club will exercise reasonable care for the safety of dogs competing, but will not be responsible for loss or damage or injury to any dog, handler, or property.

In an effort to avoid any unnecessary distraction during the test, we ask that each owner who is observing the test be responsible for his/her dog in regard to barking and other noise. Please keep all dogs who are not working inside your vehicle while in vicinity of the tracks. The AKC Tracking Regulations Chapter 1, Section 17 state: "Due to the changing nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be 'on lead' at all times on any area of the tracking site".

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Please clean up after your pet. There will be NO restroom facilities at the test site.

If, due to extreme weather, it becomes necessary to cancel the event, the Test Secretary will notify all entrants in a timely manner.
