# President's Message



At the Indian Nations Tracking Club test in Skiatook, OK, my Cocker Spaniel, Zubie earned his TD!

We drew the second track so it was still cool and damp. We watched the first team, David Bull and Wally motor through their track and then it was our

Just 9 minutes from flag to glove. I had to look at the track layers map to figure out where we had been. Zubie circled a little at the start flag, I don't think either of us have ever seen a tracking flag that big, then he put his nose down and took off with me hanging on for dear life. The vegetation was as tall or taller than Zubie and hid lots of boulders, rocks, holes, cracks, gullies, and stickery things (that's a technical term you know).

Our track ran straight away from the gravel road, Zubie went left and left again so in my brain, all I knew at that point was we better turn right soon because I didn't think a TD track could/would cross the gravel road. Sure enough, Zubie took a right turn and took off even faster. I was forced to look down a few times to stay on my feet as Zubie went down and after a slight hesitation, took off up the hill. I think he was out past 30 feet while I figured out how to safely jump across a gully. I was starting to get really worried... is he on the track, will he find the glove, and have we missed a turn since this leg seems to go forever. Somewhere along that leg, I felt like I had picked the wrong tree to line up to where Zubie was heading. Zubie stopped, hesitated for a few seconds and then I saw it, just as he slapped it... the **GLOVE!!!** 

I hustled up the line as fast as I could to wave the glove and tell my sweet boy how well he had done. The judge's maps show Zubie was step for step with the track layer.

Zubie is my first conformation champion, my novice A agility dog, and now my first tracking dog. We aren't done playing yet. Now to work TDX/VST tracks so we can play some more.
