

#### ENTRY INFORMATION

**ELIGIBILITY:** The TDU test is open to all AKC-registered dogs (including AKC Canine Partners) who have a current certification. The VST test is open to all AKC-registered dogs who have earned a TD or TDU title. Dogs may enter either test who have already earned the title for the entered test, but priority in drawing for participants will be given to dogs not yet having earned that title.

**CERTIFICATION:** A written statement must accompany each TDU entry for any dog that has not previously passed an AKC TD or TDU Test. This statement must be dated within two years of the date the test is to be held, signed by either person approved to judge tracking tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily performed a certification test.

**ENTRY FEE:** \$125.00 for VST and \$65 for TDU (includes \$0.50 AKC recording fee and \$3.00 event service fee) must be paid in U.S. funds, payable to DFWTC. DO NOT send entries by any service that requires a signature for delivery. No fax or phone entries allowed.

**EMAIL NOTIFICATION:** A notice will be sent when an entry is received as long as an email address is provided on the entry form.

CLOSING/DRAWING FOR TEST PARTICIPANTS: This test will close at 6:00 pm CDT on Thursday, October 31, 2019. The entry is limited to four (4) TDU doas and four (4) VST dogs. Preference for (1) TDU and (1) VST track will be given to DFWTC test workers who submit a full or (2) half DFWTC issued worker certificate(s) with their entry form. The test worker draw option will be used in this test as allowed by the AKC Tracking Regulations (Chap 1, Sec. 17d). In accordance with AKC Tracking Regulations, entries in this test will be accepted up to the official closing date and time, even though the advertised limit may have been reached. Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the test will be held Thursday, October 31, 2019 at 6:30 p.m. CDT at 8425 Whistling Duck Dr. Fort Worth, TX 76118. This drawing will be conducted by the Test Secretary and shall be completely random among all entries received, except that the draw shall be conducted as follows 1) test worker draw TDU, 2) draw with dogs without a title, 3) draw for remaining TDU entries, 4) test worker draw for VST, 5) draw for dogs without a VST title, and 6) draw for remaining VST entries. Once the available tracks have been filled for a given test, remaining entries will be drawn for positions on the respective alternate list. Alternates will be given the option to accept or decline being placed on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who decline will have their entry fees returned.

#### TEST INFORMATION

**PRACTICING AT THE TEST SITES:** No entered dogs should be on EITHER test site within 3 days of the test. Only test officials and personnel may be at the test sites the day prior to the event.

**BITCHES IN SEASON MAY PARTICIPATE** given the Test Secretary is notified prior to the drawing of tracks (AKC Tracking Regulations, Chapter 2, Section 8).

**DRAWING FOR TRACKING ORDER:** The drawing for tracking order will be held at 8:00 AM CST on November 10, 2019 at the Test Headquarters (Main Fire Station). The assignment of dogs to the tracks is the responsibility of the judges.

Please note that the drawing for tracking order will be held indoors, and all dogs must remain outside the building.

**REFRESHMENTS:** Coffee and light pastries will be available on the morning of the test. A lunch is planned following the completion of the test. Water and ice tea will be available. Awards will be presented during the lunch.

**ENTRY FEES WILL BE REFUNDED FOR:** (a) an alternate who does not run in the test, and (b) a dog drawn into the test that does not run, provided a properly entered alternate runs in their place. Refunds will be mailed within seven (7) days following the test.

**ENTRY FEES WILL NOT BE REFUNDED** in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from participation by action of the Test Committee.
