AKC National Tracking Invitational Postponed

It is with deep regret that we announce the AKC National Tracking Invitational, set to begin on October 23, 2020, will be postponed to 2021 as the world continues efforts to slow the coronavirus pandemic. After meeting on June 27th we the steering committee, composed of members of the Cornhusker Kennel Club and the Nebraska Kennel Club, concluded we cannot host this prestigious event with the grandeur it deserves based on the current circumstances. We also felt it was unfair to the judges, potential exhibitors, spectators and volunteers to ask them to make the difficult decision of participating given all the uncertainties of travel, lodging and safety at this time.

We have begun looking at dates in September and October of 2021 for rescheduling the event. We expect to host the 2021 AKC National Tracking Invitational at the Branched Oak State Recreation Area near Raymond, NE.
