We had two teams who demo'd. John and Pandora Galbraith with Groot and Mayhem. This gave the observers a view of two very distinct working dogs. In SAR, Bloodhounds, Labs, and GSD, are very prevalent in the working dogs. Dogs need to have stamina to search for long periods of time. We showed the CAP observers how we start surface neutral with the article game, and how we maintain for competition with our 60/50/50 tracks. The great thing was, with tracks down, a team doing their compass work walked directly over a track (cross-tracks!) and the observers got to watch the dogs work that scent situation out.

CAP was so impressed with the training at DFWTC, they have invited us back for their remaining training days this year, including an overnight stay at Lake Ray Roberts in November.

I'd like to thank John and Pandora for coming out to work their dogs. If you are interested in one of these demonstrations, please let me or Cindi Todd know.

Report of the President: Welcome guests. Thank everyone for attending yet another outdoor meeting. Originally planned to hold our first indoor meeting in over a year and a half but with the new Delta variant becoming more of a concern it was more prudent to hold this meeting outdoors. ## CH CT Tilbury's Tomorrow's Another Day of Pal

On April 26, 2012, Donna and I drove to Baldwin City, KS, to pick up a puppy bitch. The Cramer's had sent us pictures of two bitches. One was smaller but the one they felt was pick bitch and the other was a larger girl. Both were very nice but we knew we had to lay hands on them and see how each would interact with us and the other pups in the litter. We spent the night mulling over the pros and cons of each. The next morning after breakfast it was difficult but a decision was made. I reached into the ex-pen and picked up the larger girl and told her that she was going with us to Texas. As it turned out it was a win win for both parties. The Cramers, even though they allowed us first pick, really wanted to keep the smaller



girl. On the drive home we named our new girl Tilbury's Tomorrow's Another Day of Pal - Scarlett.



Scarlett easily fit in with our other two Pal Dal bred dogs - Seeker and Sydney - and Kali, our liver bitch. I immediately started training her for tracking but in the Fall it became evident that Scarlett had potential to be a show dog. We sent her off on the show circuit with Collette Livingston. Unfortunately during the first few months out there were no Dalmatian bitch entries to compete against. Finally in Minnesota she won her first points and continued on to earn her Championship in March of 2013.

Back to tracking we went and I felt it was time to start on the road to tracking titles. Scarlett was the first of my dogs to NOT certify on the first try - nor the second - but finally on our third attempt. Then on to the TD tests and the same routine occurred - it took three tries. After that things changed. The tension of the handler had been alleviated and everything clicked and kicked in. After the usual alternate game was played she earned her TDX and 19 days later passed her VST to become a Champion

Tracker. She became a loving pet and couch dog - my bad for not doing Scent Work with her.

About five years later I decided to see how she'd do on a track so while aging a 800 yard 3-1/2 hour old track for Dove I laid her a 500 yard TD track aging it just an hour and a half. After I got her out of the vehicle she dragged me the 100 yards to the blind start flag. I put her harness on and off we went and less than five minutes later we were at the final article. She duplicated this same scenario about two months later and at that final article Charlene asked me if I felt I could keep up with her if

we were drawn as one of the lucky 12 for the NTI. I said no way - that I'd have to have someone younger like Charlene handle her. They never forget how to do something they really love and that's to track. She went from a two time certification and TD test failure to become a dynamic tracking dog.

She was a beautiful, loyal and loving companion and we miss her dearly. Our original Pal Dal pack of Seeker, Sydney and Scarlett are together again. Be patient - Mom and I will join you in time.
