

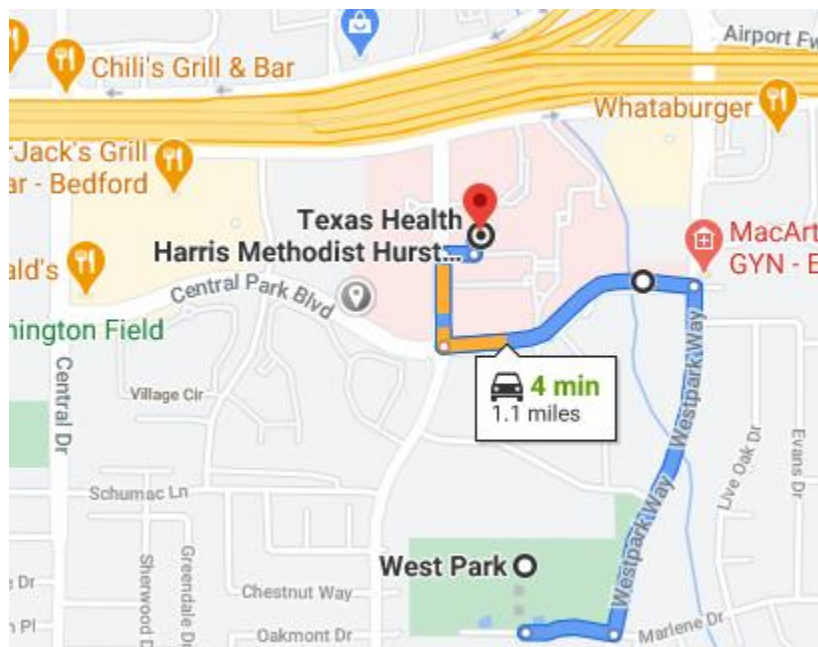

**EXCHANGES:** If the limit for entries is not reached in one test and the limit for entries is exceeded in the other test, the number of tracks may be exchanged up to the day of plotting. The following substitution will be in effect 2TDU's = 1 VST (AKC Tracking Regulations, Chapter 1, Section 17a and 19). Site limit for TDU is 5.

## ENTRY INFORMATION

**ELIGIBILITY:** The TDU test is open to all AKC-registered dogs (including AKC Canine Partners) who have passed a certification track. The VST test is open to all AKC-registered dogs who have earned a TD or TDU title. Dogs may enter either test who have already earned the title for that test, but priority in drawing for participants in the TDU test will be given to dogs not yet having earned an AKC tracking title and in the VST test to dogs not yet having earned the VST title.

**CERTIFICATION:** A written statement must accompany each TDU entry for any dog that has not previously passed an AKC TD or TDU Test. This statement must be dated within two years of the date the test is to be held, signed by either person approved to judge tracking tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily perform a certification test.

**ENTRY FEE:** \$125.00 for VST and \$65 for TDU (includes \$0.50 AKC recording fee and \$3.00 event service fee) must be paid in U.S. funds, payable to DFWTC. DO NOT send entries by any service that requires a signature for delivery. No fax or phone entries allowed.

**EMAIL NOTIFICATION:** A notice will be sent when an entry is received as long as an email address is provided on the entry form.

**CLOSING/DRAWING FOR TEST PARTICIPANTS:** This test will close at 6:00 pm CST on Thursday, January 7, 2021. The entry is limited to two (2) TDU dogs and four (4) VST dogs. Preference for (1) VST track will be given to DFWTC test workers who submit a full or (2) half DFWTC issued worker certificate(s) with their entry form. The test worker draw option will be used in this test as allowed by the AKC Tracking Regulations (Chap 1, Sec.17d). In accordance with AKC Tracking Regulations, entries in this test will be accepted up to the official closing date and time, even though the advertised limit may have been reached. Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the test will be held Thursday, January 7, 2021 at 6:30 p.m. CST at 8425 Whistling Duck Dr. Fort Worth, TX 76118. This drawing will be conducted by the Test Secretary and shall be completely random among all entries received, except that the draw shall be conducted as follows 1) draw with dogs without a title, 2) draw for remaining TDU entries, 3) test worker draw for VST, 4) draw for dogs without a VST title, and 5) draw for remaining VST entries. Once the available tracks have been filled for a given test, remaining entries will be drawn for positions on the respective alternate list. Alternates will be given the option to accept or decline being placed on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who decline will have their entry fees returned.

## TEST INFORMATION

**PRACTICING AT THE TEST SITE:** No entered dogs should be on the test site within 3 days of the test. Only test officials and personnel may be at the test site the day prior to the event.

**BITCHES IN SEASON MAY PARTICIPATE** given the Test Secretary is notified prior to the drawing of tracks (AKC Tracking Regulations, Chapter 2, Section 8).

**DRAWING FOR TRACKING ORDER:** The drawing for tracking order will be held at 8:00 AM CST on January 17, 2021 at the Test Headquarters (West Park). The assignment of dogs to the tracks is the responsibility of the judges.

**REFRESHMENTS:** Due to COVID-19 we will not be able to provide refreshments. We will have bottled water available. Awards will be presented at the conclusion of the event at test headquarters.

**ENTRY FEES WILL BE REFUNDED FOR:** (a) an alternate who does not run in the test, and (b) a dog drawn into the test that does not run, provided a properly entered alternate runs in their place. **In the event the test cannot be held or completed due to COVID-19 restrictions we will refund entry fees and certifications.** Refunds will be mailed within seven (7) days following the test.

**ENTRY FEES WILL NOT BE REFUNDED** in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from participation by action of the Test Committee. No entry fee will be refunded if the test cannot be held or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strike and/or any other cause beyond the control of the Club or Test Secretary.

**EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS' RECOMMENDATION** to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**BY THEIR PRESENCE** on the Tracking grounds, all exhibitors and spectators agree to abide by AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. DFW Tracking Club will exercise all reasonable care for the safety of dogs, handlers, and spectators, but will not be responsible for any loss, damage, or injury to any dog or person on the test grounds. AKC Tracking Regulations Chapter 1 Section 6: "Owners or agents entering dogs in tracking tests do so at their own risk and agree to abide by all AKC rules and regulations..." Only dogs that are entered in the test will be allowed in the Tracking area. Dogs will be required, at all times, to be on leash or in a vehicle.

**AGREEMENT**

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

**INSTRUCTIONS**

- (Variety) If you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
