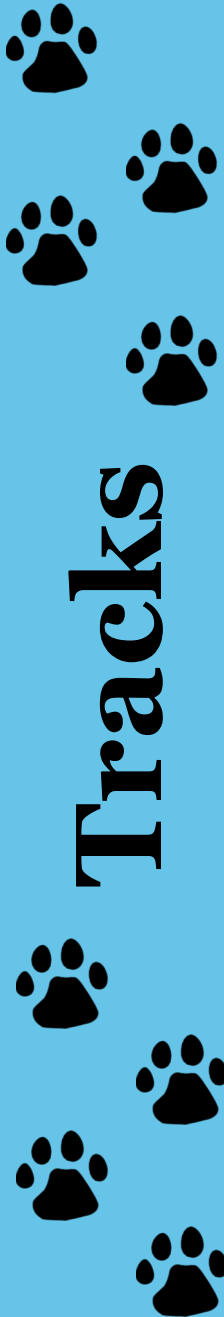

Report of President - Absent

Report of Treasurer - Income and expense statement passed around. We have money, we spent money.

New ribbons for placement and qualifying will be ordered. New title ribbon number will be bumped.

Committee includes Jeanine as secretary, Tracy as Chair. Need more committee members and workers to pull this off.

Camp Carter needs deposit of \$675.00 to hold our weekend.

Motion was made to hold the trial by Benita. Tom seconded.

New Business:

1. Winter classes will tentatively be held at Park Hill. Sarah prefers this site and will use TCC SE as backup. Class registration opens 12/1/22
2. Discussed test pricing. Denver went up to \$150 for their VST to try and cover costs.

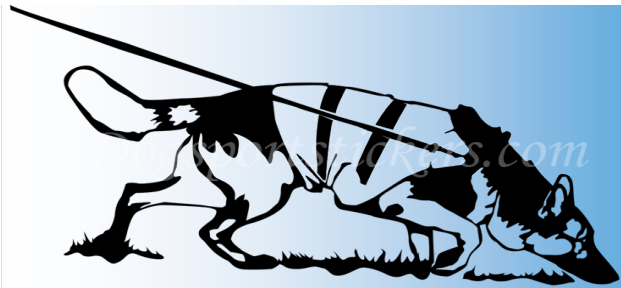
