

ENTRY INFORMATION

ELIGIBILITY: The TDU test is open to all AKC-registered dogs (including AKC Canine Partners) who have passed a certification track. The VST test is open to all AKC-registered dogs who have earned a TD or TDU title. Dogs may enter either test who have already earned the title for that test, but priority in drawing for participants in the TDU test will be given to dogs not yet having earned an AKC tracking title and in the VST test to dogs not yet having earned the VST title.

CERTIFICATION: A written statement must accompany each TDU entry for any dog that has not previously passed an AKC TD or TDU Test. This statement must be dated within two years of the date the test is to be held, signed by either person approved to judge tracking tests, or by a person/ evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily perform a certification test.

ENTRY FEE: \$125.00 for VST and \$65 for TDU (includes \$0.50 AKC recording fee and \$3.00 event service fee) must be paid in U.S. funds, payable to DFWTC. DO NOT send entries by any service that requires a signature for delivery. No fax or phone entries allowed.

EMAIL NOTIFICATION: A notice will be sent when an entry is received as long as an email address is provided on the entry form.

CLOSING/DRAWING FOR TEST PARTICIPANTS: This test will close at 6:00 pm CST on Thursday, January 6, 2022. The entry is limited to two (2) TDU dogs and four (4) VST dogs. Preference for (1) VST track will be given to DFWTC test workers who submit a full or (2) half DFWTC issued worker certificate(s) with their entry form. The test worker draw option will be used in this test as allowed by the AKC Tracking Regulations (Chap 1, Sec.17d). In accordance with AKC Tracking Regulations, entries in this test will be accepted up to the official closing date and time, even though the advertised limit may have been reached. Should the number of entries exceed the number of tracks available, a drawing to determine which entries will participate in the test will be held Thursday, January 6, 2022 at 6:30 p.m. CST at 8425 Whistling Duck Dr. Fort Worth, TX 76118. This drawing will be conducted by the Test Secretary and shall be completely random among all entries received, except that the draw shall be conducted as follows 1) draw with dogs without a title, 2) draw for remaining TDU entries, 3) test worker draw for VST, 4) draw for dogs without a VST title, and 5) draw for remaining VST entries. Once the available tracks have been filled for a given test, remaining entries will be drawn for positions on the respective alternate list. Alternates will be given the option to accept or decline being placed on the alternates list. Those who accept will be placed on the alternates list in the order in which they were drawn. Those who decline will have their entry fees returned.

TEST INFORMATION

PRACTICING AT THE TEST SITES: No entered dogs should be on EITHER test site within 3 days of the test. Only test officials and personnel may be at the test sites the day prior to the event.

BITCHES IN SEASON MAY PARTICIPATE given the Test Secretary is notified prior to the drawing of tracks (AKC Tracking Regulations, Chapter 2, Section 8).

DRAWING FOR TRACKING ORDER: The drawing for tracking order will be held at 8:00 AM CST on January 16, 2022 at the Test Headquarters (Main Fire Station). The assignment of dogs to the tracks is the responsibility of the judges.

Please note that the drawing for tracking order will be held indoors, and all dogs must remain outside the building.

REFRESHMENTS: Coffee and light pastries will be available on the morning of the test. A lunch is planned to follow the completion of the test. Water and iced tea will be available. Awards will be presented during the lunch.

ENTRY FEES WILL BE REFUNDED FOR: (a) an alternate who does not run in the test, and (b) a dog drawn into the test that does not run, provided a properly entered alternate runs in their place. Refunds will be mailed within seven (7) days following the test.

ENTRY FEES WILL NOT BE REFUNDED in the event a dog is absent, disqualified, excused by a veterinarian or judge, or barred from participation by action of the Test Committee. No entry fee will be refunded if the test cannot be held or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of public enemy, strike and/or any other cause beyond the control of the Club or Test Secretary.

EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS' RECOMMENDATION to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

BY THEIR PRESENCE on the Tracking grounds, all exhibitors and spectators agree to abide by AKC Rules and Regulations and to follow the instructions of the Test Committee to the best of their ability. DFW Tracking Club will exercise all reasonable care for the safety of dogs, handlers, and spectators, but will not be responsible for any loss, damage, or injury to any dog or person on the test grounds. AKC Obedience Regulations: "The owner or agent entering a dog in an obedience trial (tracking test) does so at his own risk..." Only dogs that are entered in the test will be allowed in the Tracking area. Dogs will be required, at all times, to be on leash or in a vehicle.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
